Report shared with the board, along with the update that the Finance Committee has approved \$75K appropriation from Capital to pay for the BRYX installation.

VII. DISCUSSION ON ESTABLISHING COMMITTEE FOCUS

The board discussed the possibility of restructuring the committees as well as possibly removing the finance committee from the District structure. Members will check in with their staff, and do more research for further discussion at the next meeting.

VIII. NVRDD GROWTH DISCUSSION

- 1. Hudson Update: NVRDD has been working with Hudson Public Safety on the needs for the transition onto NVRDD. Quotes have been received and the Grant Application has been filled out and submitted to State 911.
- 2. Marlborough: Director Camaro gave an update on meetings she's had with the Marlborough Mayor, especially with regards to division of assessments and the conveyance of land within the Town of Marlborough to the District. The Board had a lengthy response about the implications of taking on a large city, and of moving the District's Headquarters to the City of Marlborough.
- 3. Sterling: Director Camaro advised the board that she has met with the Town of Sterling and their Public Safety Departments about the possibility of joining the District.
